Resolution No. 2016-129

RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES REGION 6 (DENR-6) FOR THE SUBDIVISION OF THE BLISS SITE TO ACTUAL OCCUPANTS AND ISSUANCE OF CORRESPONDING RESIDENTIAL FREE PATENT COVERING PLAN N6-06-000005 LOCATED AT BARANGAY TAN PAEL, TIGBAUAN, ILOILO.

WHEREAS, the BLISS Project was established sometime in 1980 under the Ministry of Human Settlements and is being managed by the Home Guaranty Corporation, one of the government owned and controlled corporations and implementing arm of the Rural BLISS I Social Housing Project;

WHEREAS, in 2001, the Municipal Council passed Resolution No. 2001-037, authorizing the Municipal Government of Tigbauan, Province of Iloilo thru Municipal Mayor, Hon. Myrna M. Torres to purchase the Rural BLISS I Social Housing Project located at Brgy. Tan Pael, Tigbauan, Iloilo in the amount of P245,000.00 to be paid in cash within one (1) year without interest;

WHEREAS, the actual book value of the Rural BLISS I Housing Project is P963,803.10, nevertheless it was sold for only P245,000.00 to the Municipal Government of Tigbauan;

WHEREAS, since the establishment of the BLISS Project sometime in 1980 (*under the Ministry of Human Settlements and is being managed by the Home Guaranty Corporation, one of the government owned and controlled corporations and implementing arm of the Rural BLISS I Social Housing Project*) until the purchase made by the Municipal Government of Tigbauan, Province of Iloilo thru Municipal Mayor, Hon. Myrna M. Torres (*by virtue of a Municipal Resolution No. 2001-037*), there was no residential free patent nor any guaranty of ownership issued to actual occupants thereof;


NOW THEREFORE, on motion of HON. JOHN GERSHWIN C. TUERES, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment & Expropriation and duly seconded by Hon. Dennis T. Valencia, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Jerry Tuares and Hon. Ronnie T. Paguntalan;

RESOLVED, to request the Department of Environment and Natural Resources, Region 6 (DENR-6) for the Subdivision of the Bliss Site to Actual Occupants and Issuance of Corresponding Residential Free Patent Covering Plan N6-06-000005 Located at Barangay Tan Pael, Tigbauan, Iloilo,
