Resolution No. 2016-130

RESOLUTION ALLOCATING AND DECLARING A PORTION OF THE BLISS SITE WITH AN AREA OF 500 SQUARE METERS AS SITE FOR FISH LANDING CENTER OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, an endorsement was made by the Sangguniang Barangay of Tan Pael, Tigbauan, Iloilo thru a **Resolution No. 007-2016** – *“Resolution Accepting The Fish Landing Center Project And Its Components Of A Lot Of 500 Square Meters Located At BLISS Site”* by virtue of a public hearing conducted last October 18, 2016;

WHEREAS, the BLISS Project was established sometime in 1980 under the Ministry of Human Settlements and is being managed by the Home Guaranty Corporation, one of the government owned and controlled corporations and implementing arm of the Rural BLISS I Social Housing Project;

WHEREAS, in 2001, the Municipal Council passed Resolution No. 2001-037, authorizing the Municipal Government Of Tigbauan, Province Of Iloilo thru Municipal Mayor, Hon. Myrna M. Torres to purchase the *Rural BLISS I Social Housing Project* located at Brgy. Tan Pael, Tigbauan, Iloilo in the amount of p245,000.00 to be paid in cash within one (1) year without interest;

WHEREAS, the actual book value of the Rural BLISS I Housing Project is P963,803.10, nevertheless it was sold for only P245,000.00 to the Municipal Government of Tigbauan;

WHEREAS, after presentation of the proposed project by the personnel from the Municipal Agriculture Office, the Barangay Officials agreed to accept the Community Fish Landing Center (CFLC) located at BLISS site of this Barangay;

WHEREAS, thru Community Fish Landing Center (CFLC) Site Inspection/Evaluation conducted by the Municipal Agriculture Office, there are 41 registered fisherfolks and 31 fishing boats in the area with an average annual volume of 22.63 metric tons of fish catch;

WHEREAS, this August Body passed *Resolution No. 2016-018, Authorizing The Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada For And In Behalf Of The Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement With The Bureau Of Fisheries And*

Aquatic Resources (BFAR) And Philippine Fisheries Development Authority (PFDA) For The Establishment Of Fisheries Post Harvest Infrastructure And Facility Particularly The Community Fish Landing Center (CFLC) In Line With The Fisheries Poverty Reduction Framework Featured In The Target Program Of BFAR;

WHEREAS, Republic Act No. 8550, as amended otherwise known as the “*Philippine Fisheries Code of 1998*”, authorizes BFAR to establish post harvest facilities for fishing communities consistent with the policy of providing support to subsistence fisheries in the exercise of their preferential rights to benefit from the country’s fisheries resources especially in the municipal waters;

WHEREAS, also, Republic Act No. 7160 otherwise known as the “*Local Government Code of 1991*”, mandates the LGU to provide its constituents extension facilities related to agriculture and fishery activities which include water and soil resource utilization and conservation projects and enforcement of fishery laws in the municipal waters;


NOW, THEREFORE, on motion of HON. JOHN GERSHWIN C. TUERES, *Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation* and duly seconded by Hon. Dennis T. Valencia, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma, Hon. Jerry Tuares and Hon. Ronnie T. Paguntalan;

RESOLVED, to Allocate And Declare A Portion Of The Bliss Site With An Area Of 500 Square Meters As Site For Fish Landing Center Of The Municipality Of Tigbauan, Province Of Iloilo,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, this municipality, to Brgy. Tan Pael, Tigbauan, Iloilo, to the Office of the Municipal Agriculture and all concerned for their information and/or appropriate action.
