**Resolution No. 2016-138**

RESOLUTION EARNESTLY REQUESTING MAJOR GEN. ALEXANDER BALUTAN, GENERAL MANAGER, PHILIPPINE CHARITY SWEEPSTAKES OFFICE, FOR ONE (1) UNIT OF AMBULANCE TO BE USED BY THE RURAL HEALTH UNIT OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, way back in 2010 the Philippine Charity Sweepstakes had donated one unit of ambulance for the Rural Health Unit of the Municipality of Tigbauan and by now, is dilapidated;

WHEREAS, because of the growing population of the Municipality of Tigbauan which is composed of 52 barangays and with a present total of 65,906 inhabitants, more or less as of 2015 (actual survey), said ambulance could not satisfy and/or cater to the demands for health services of the people, this municipality;

WHEREAS, there is an immediate and dire need for an additional unit of ambulance in order to effectively serve our populace, since our only one existing ambulance is already not serviceable;

WHEREAS, due to budgetary constraints, the LGU-Tigbauan could not afford to purchase the needed additional ambulance unless it can have other sources of funds;

WHEREAS, pursuant to our ordinance, the ambulance shall be used during emergency cases as per assessment by the Municipal Health Physicians and likewise for non-emergency cases, such as fetching patients from the hospital back to his/her house, and for the private physicians who have emergency patients that need to be brought to the hospital;

NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, Committee on Peace & Order and Public Safety and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares and Hon. Ronnie T. Paguntalan,

RESOLVED, to earnestly Request Major Gen. Alexander Balutan, General Manager, Philippine Charity Sweepstakes Office, for One (1) Unit of Ambulance to be used by the Rural Health Unit of the Municipality of Tigbauan, Province of Iloilo,

RESOLVED FURTHER, to forward copies of this Resolution to Major Gen. Alexander Balutan, General Manager, Philippine, Charity Sweepstakes Office, for his favorable consideration, to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, and to all concerned for their information.
