RESOLUTION CONFORMING AND APPROVING THE CY 2017 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS BAGUMBAYAN AND BAGACAY**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 22, 2016, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2017 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

Barangay Bagumbayan CY 2017 General Annual Budget Involving an Appropriation of P2,058,324.00, 20% Development Fund in the amount of P405,064.80, and 5% BDRRMF in the amount of P102,916.20 Approved by Sangguniang Barangay on September 19, 2016 and Enacted Under Appropriation Ordinance No. 2016-02;

Barangay Bagacay CY 2017 General Annual Budget Involving an Appropriation of P1,920,450.00, 20% Development Fund in the amount of P378,390.00, and 5% BDRRMF in the amount of P96,022.50 Approved by Sangguniang Barangay on September 26, 2016 and Enacted Under Appropriation Ordinance No. 2016-02;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;


