RESOLUTION GRANTING ASSISTANCE AS LGUS SUPPORT ACTIVITIES TO FIVE HUNDRED FORTY THREE (543) BARANGAY RESPONDERS IN THE TOTAL AMOUNT OF TWO HUNDRED SEVENTY ONE THOUSAND FIVE HUNDRED PESOS (P271,500.00) AT FIVE HUNDRED PESOS (P500.00) EACH IN RECOGNITION OF THE VALUABLE SERVICES THEY HAVE RENDERED IN THEIR RESPECTIVE BARANGAYS

WHEREAS, Chapter 2 Section 387 (b) of the Local Government Code provides that the Sangguniang Barangay may form community brigades and create such other positions or offices as may be deemed necessary to carry out the purposes of the barangay government in accordance with the needs of public service, subject to the budgetary limitations and personal services prescribed under Title Five, Book II of this Code;

WHEREAS, Chapter 4 Section 391 No. 16, of the same Code, mandates the Sangguniang Barangay, as the legislative body of the barangay, to provide for the organization of community brigade, barangay tanod or community service unit as may be necessary;

WHEREAS, the Barangay tanods, as watchmen of the barangay under the supervision of the barangay captain, perform a variety of police functions; they are the "front liners in the preparation and response to any type of atrocities, public disorders, emergencies and even disasters or man-made calamities that threaten peace and order and public safety." They may be either unarmed or armed simply, with a truncheon or a *batuta*;

WHEREAS, a barangay tanod, also known as a barangay police officer -- and sometimes as BPSO (which can stand for barangay peace and security officer, barangay peacekeeping and security officer, or barangay police safety officer) -- is the lowest level of law enforcement officer in the Philippines;

WHEREAS, in recognition of their efforts and valuable services, the Local Government Unit of Tigbauan will be granting this year-end of 2016, the total amount of P271,500.00 as LGU's support activities to 543 Barangay Responders at P500.00 each; WHEREAS, the said amount (P271,500.00) will be charged from the 5% MDRRM Fund-Support Activities to Responders & Volunteers;
