RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION WITH THE PHILIPPINE NATIONAL POLICE (PNP) THRU THE ACTING PROVINCIAL DIRECTOR, PSSUPT. HAROLD B. TUZON IN CONNECTION WITH THE LOT BOUGHT FROM THE ZAYCO FAMILY FOR THE CONSTRUCTION OF THE TIGBAUAN MUNICIPAL POLICE STATION.

WHEREAS, in line with the *PNP modernization program*, the National Government has launched its Program to finance the construction of a standard PNP building and facilities for LGUs once it could provide a parcel of land as site thereof with a minimum area of four hundred (400) square meters;

WHEREAS, the Municipal Officials of the Local Government Unit of Tigbauan recognize the importance and necessity of availing of such project;

WHEREAS, on October 19, 2016 during its 43rd Regular Session, this August Body, pursuant to the urgent request of Mayor Alquisada, passed **Resolution No. 2016-117**, *"RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT TO SELL/DEED OF SALE WITH THE ZAYCO FAMILY FOR THE PURCHASE OF LOT FOR THE USE OF THE TIGBAUAN MUNICIPAL POLICE STATION IN THE AMOUNT OF FIVE THOUSAND PESOS (P5,000.00) PER SQUARE METER"*;

WHEREAS, pursuant to Resolution No. 2016-117, the Municipality of Tigbauan represented by the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, purchased Lot No. 928-E-2-A with an area of 400 square meters from the Zayco Family on November 7, 2016 for the use of the Tigbauan Municipal Police Station;

WHEREAS, another requirement in order to avail of such project is for this August Body to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to enter into a Deed of Donation with the Philippine National Police (PNP) over the acquired property;

WHEREAS, with the execution of the deed of donation and submission of other required documents, the Officials of LGU-Tigbauan firmly believe that this municipality could avail of the PNP modernization program, *the construction of a standard PNP building and facilities*;

NOW THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Peace and Order and Public Safety* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry Tuares and Hon. Ronnie T. Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to Enter Into A Deed of Donation With the Philippine National Police (PNP) thru Acting Provincial Director, PSSUPT Harold B. Tuzon in Connection With the Lot Bought From the Zayco Family for the Construction of the Tigbauan Municipal Police Station,
