RESOLUTION APPROVING THE APPLICATION FOR SUBDIVISION APPROVAL NO. SA-12-16-313 OF **GLORIA T. NULADA** WITH OCT T-108416, LOT NO. 601, WITH AN AREA OF 1,664 SQ. M. MORE OR LESS, CONTAINING FIVE (5) LOTS LOCATED AT BRGY. BARROC, TIGBAUAN, ILOILO.

WHEREAS, the Application for Subdivision Approval No. SA-12-16-313 of **GLORIA T. NULADA** with OCT NO. T-108416, Lot No. 601, with an area of 1,664 sq. m. more or less, containing FIVE (5) lots located at Brgy. Barroc, Tigbauan with attached supporting documents was submitted by the Evaluating Officer to the Office of the Sangguniang Bayan, Tigbauan, Iloilo on December 8, 2016 for authorization and approval;

WHEREAS, the purpose/intent of this application is to subdivide among heirs/co-owners;

WHEREAS, the said land parcel was classified as residential area in the zoning classification;

WHEREAS, the conditions of said approval shall be the following:

- In the event of partial submission of subdivision plans, the same shall be considered in its entirety and applicable provisions of PDs 957 & 1216, or BP 220 shall be observed;
- Comply with all the corrections as indicated on the plan;
- Any misrepresentation or material falsehood on the part of the applicant shall be a sufficient cause for the cancellation of this approval and/or legal action;
- This approval does not exempt the proponent from pertinent requirements of other government agencies;
- This approval does not exempt the proponent from securing registration and license to sell from HLURB.
