RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION WITH THE BUREAU OF FIRE PROTECTION (BFP) – TIGBAUAN FIRE STATION FOR THE DONATION OF WATER TANKER WITH PLATE NO. (SGK 629), MULTICAB WITH PLATE NO. (SLC 320) AND RESCUE BOAT.

WHEREAS, in line with the *Bureau of Fire Protection (BFP) modernization program*, there is a need for the formal turnover of all equipment owned by LGU- Tigbauan which are presently used by the BFP– Tigbauan Fire Station, as a requirement so that the BFP could shoulder all the expenses for the major repairs/maintenance and registration of the said equipment;

WHEREAS, this formal turnover could be done through a Deed of Donation of all equipment which are owned by the LGU-Tigbauan and are being used by the BFP– Tigbauan Fire Station, namely: *the Water Tanker with Plate No. SGK 629, Multicab with Plate No. SLC 320 and the Rescue Boat* ;

WHEREAS, during the 5th Regular Session of the Sangguniang Bayan dated February 1, 2017, the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada has requested for the urgent passage of a *“RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION WITH THE BUREAU OF FIRE – TIGBAUAN FIRE STATION FOR THE DONATION OF WATER TANKER WITH PLATE NO. (SGK 629), MULTICAB WITH PLATE NO. (SLC 320) AND RESCUE BOAT”*;

WHEREAS, with the execution of a Deed of Donation, the BFP-Tigbauan Fire Station could further request for an additional personnel from the Provincial Fire Station to man said equipment considering that presently the BFP-Tigbauan lacks the needed personnel;


NOW THEREFORE, on motion of ATTY. VIRGILIO T. TERUEL, *Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters* and duly seconded by Hon. Dennis Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, and Hon. Jerry Tuares;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to Enter Into A Deed of Donation With the Bureau Of Fire Protection– Tigbauan Fire Station for the Donation of Water Tanker with Plate No. (SGK 629), Multicab with Plate No. (SLC 320) and Rescue Boat;

RESOLVED FURTHER, to furnish copies of this Resolution the Office of the Municipal Mayor, and to all concerned for their information and guidance.
