RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE ESTABLISHMENT OF THE RAINWATER HARVESTING SYSTEM IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, all parties agree to uphold the objectives of the Watershed Management/Freshwater Management Program which are:

- To advocate and create structures and systems that will institutionalize watershed management as a development strategy;
- To demonstrate the use of Rainwater Harvesting facilities to adapt to the impacts of Climate Change; and
- To promote rainwater harvesting in the parties' areas of influences so that more sectors and stakeholders will understand its benefits.

WHEREAS, in the adoption of Rainwater Harvesting Technology in the Municipality, there is a need to facilitate the effective and sustainable implementation of the project;

WHEREAS, the Municipality of Tigbauan and Iloilo Provincial Government, Province of Iloilo, have manifested their desire to jointly adopt the establishment of the Rainwater Harvesting System in Evacuation areas to ensure attainment of the abovementioned objectives;

WHEREAS, for and in consideration of the foregoing premises, both parties hereby agree to cooperate for the effective and efficient implementation and management of the Rainwater Harvesting System in Evacuation Center of the Municipality with the following obligations and responsibilities;

A. The Iloilo Provincial Government (First Party):

- Provide the needed fund to construct the Rainwater Harvesting System in the evacuation center of the Second Party;
- Provide technical, and other forms of assistance deemed necessary to ensure the success of the project;
- Conduct spot visit during and after the construction of the facility;

4. *Install billboards in recognition of the joint efforts of the project; and*
5. *Monitor, evacuate, and document the project for proper reporting and see to it that the facilities are functioning and taken cared by the Second Party.*

B. The Municipality of Tigbauan (Second Party):

1. *Provide the area/facility site (Tigbauan National High School Evacuation Center) and the fund for the labor component of the facility;*
2. *Conduct regular inspection and maintenance of the facility and ensure that it is functioning well;*
3. *Ensure that the facility will be used to store rainwater with the aim of saving water, reducing run-off, enhancing recharge of groundwater and reducing extraction of groundwater;*
4. *Ensure that the facility will be installed in the evacuation center and will be used as source of water for potable and other uses during evacuation;*
5. *Encourage the full participation and involvement of the community during the implementation stage;*
6. *Submit progress and development reports of the project and any problems which may arise;*
7. *Upon project completion, the Municipality will assume the full responsibility in the care, maintenance and protection of the facility in any form of unforeseen events. Likewise, the Municipality and its constituents will be the primary beneficiary of the project.*

NOW, THEREFORE, on motion of HON. JOHN GERSHWIN C. TUERES, Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation and duly seconded by Hon. Dennis T. Valencia, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry Tuares and Hon. Ronnie T. Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality Of Tigbauan To Enter Into A Memorandum Of Agreement With The Iloilo Provincial Government For The Establishment Of The Rainwater Harvesting System In The Municipality Of Tigbauan, Province Of Iloilo;
