RESOLUTION STRONGLY URGING THE ILOILO-I ELECTRIC COOPERATIVE (ILECO-I) MANAGEMENT AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), PROVINCIAL AND REGIONAL OFFICES AND TELEPHONE COMPANIES (TELECOM-GLOBELINES, PLDT), TO REMOVE/TRANSFER ALL ELECTRIC POSTS ALONG THE NATIONAL HIGHWAY WITHIN THE JURISDICTION OF THE MUNICIPALITY OF TIGBAUAN WHICH ARE OR SHALL BE AFFECTED BY THE ON-GOING WIDENING OF THE NATIONAL HIGHWAY BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS.

WHEREAS, the Department of Public Works and Highways has been undertaking a national highway widening project from the Municipality of Oton to the Municipality of San Joaquin in the First Congressional District of Iloilo;

WHEREAS, the project has reached or covered the areas where the ILECO-I electric posts are installed such that these posts can be seen standing in the middle of some completed portions of the widening project within the territorial jurisdiction of the Municipality of Tigbauan;

WHEREAS, such electric posts render the widening project useless since the widened portion of the highway cannot be used by vehicles and more importantly, they pose as dangers and hazards to motorists and pedestrians;

WHEREAS, considering the importance and urgency of the matter the members of the Sangguniang Bayan unanimously agreed to bring it to the attention of the ILECO-I management, DPWH and Telephone Companies (Telecom-Globelines, PLDT),for consideration and prompt favorable action;


NOW, THEREFORE, on motion of VICE MAYOR VIRGILIO T. TERUEL, *Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters* and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares and Hon. RonnieT.Paguntalan,

RESOLVED, to strongly urge the Iloilo-I Electric Cooperative (ILECO-I) Management, the Department of Public Works and Highways (DPWH) and Telephone Companies (Telecom-Globelines, PLDT), Iloilo Provincial and Regional Offices, to Remove/Transfer All Electric Posts Along the National Highway Within the Jurisdiction of the Municipality of Tigbauan Which are or Shall Be Affected by the On-Going Widening of the National Highway by the Department of Public Works and Highways,

RESOLVED FURTHER to furnish copies of this Resolution to the ILECO-I Management, Tigbauan, Iloilo, to DPWH Regional Office, Region VI, Iloilo City and Iloilo Provincial Office, to Telephone Companies (Telecom-Globelines, PLDT), to Mayor Suzette Tenefrancia-Alquisada, this municipality and all concerned for their information, consideration and prompt favorable action.
