Resolution No. 2017-041

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB) ILOILO, REGION VI FOR THE IMPLEMENTATION OF THE MATERIAL RECOVERY FACILITIES (MRFs) PROJECT IN LGU - TIGBAUAN, ILOILO.

WHEREAS, the Ecological Solid Waste Management Act of 2000 (RA 9003), provides for an ecological waste management program, creating the necessary institutional mechanisms and incentives, and appropriating funds therefore, and for other purposes;

WHEREAS, Section 8 of RA 9003, mandates the Department to provide support to the LGUs in the development and implementation of local solid waste management plans, and programs;

WHEREAS, Section 32 of RA 9003, mandates the establishments of Materials Recovery Facility (MRF) in every barangay or cluster of barangays;

WHEREAS, Section 20 of RA 9275 states that local government units shall share the responsibility in the management and improvement of the environment within their territorial jurisdiction;

WHEREAS, the EMB recognizes the possible impact of an organized intensive countrywide waste recovery system and has thus adopted it as part of the priority effort;

WHEREAS, as part of this effort, there is a need to promote, showcase and convince the local government of a supplemental waste recovery initiative that can be readily integrate into their existing Solid Waste Management (SWM) programs, and that, such initiative is both environmentally and economically beneficial;

WHEREAS, the Agreement is being made to establish such supplemental pilot projects to wit: Material Recovery Facilities (MRFs) in LGU- TIGBAUAN, at TIGBAUAN ILOILO;

WHEREAS, this MRF project will adopt/utilize local, low cost, low to medium technologies to recover waste materials for re-use, recycling, recovery and re- introduction into the process, significantly reduce the waste stream, create employment opportunities and generate economic activity;

WHEREAS, the said project is due for completion within the Calendar Year 2017;

WHEREAS, for and in consideration of these premises and the mutual covenants herein contained, the PARTIES do hereby agree and bind themselves to collaborate their efforts for the objectives of RA 9003, particularly in the establishment and operation of Material Recovery Facility (MRF) and proper segregation at source to address the solid waste management problems in the Municipality in order to achieve its shared objective of effectively protecting the environment and safeguard the health of the people; specifically, the parties herein agree to the following roles and responsibilities in the implementation of the Material Recovery Facility (MRF) project;

Section 1. Role of the FIRST PARTY:

- 1. Provide technical assistance to SECOND PARTY (LGU- TIGBAUAN) in the conduct of Waste Analysis and Characterization Survey (WACS) and in the formulation/ updating of the Municipal 10- year SWM Plan and planning of Barangay Solid Waste Management Plan and implementation of the Material Recovery Facility (MRF) project;
- 2. Perform the monitoring, evaluation and documentation process to ensure attainment of the project;
- 3. Be responsible for the disbursement /cash transfer of the national funds in the amount of **THREE HUNDRED SEVENTY FIVE THOUSAND (Php 375,000.00)** to be provided therein and ensures that the allotment shall be used solely for the construction of the new MRF structure.

Section 2. Role of the SECOND PARTY:

- 1. Assist its component barangays in the development of the Barangay Solid Waste Management Plan that will ensure the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of Material Recovery Facility (MRF) Projects in the barangay within its respective areas of jurisdiction;
- 2. Assist the recipient barangays to promote and ensure viability and effective implementation of solid waste management program for the barangay;
- 3. Develop and submit a Work and Financial Plan (WFP) for the activities that will be conducted which shall form part of this agreement;
- 4. Provide counter resources to assist/augment the implementation of this Agreement as follows:
 - Available area/lot for the establishment of Material Recovery Facility (MRF) (owned by the LGU)
 - Designate/appoint Material Recovery Facility (MRF) site Supervisor Municipal Environment and Natural Resources Officer (MENRO) and Personnel to manage the recording system of MRF operation, provide IEC to the residents, and implement the processing of Material Recovery Facility (MRF);
 - Other forms of support needed for the project.
- 5. Establish and maintain the Material Recovery Facility (MRF) in accordance to specifications as agreed upon by the parties;
- 6. Implement the mandates of RA 9003 which is segregation at source and segregated collection;
- 7. Divert at least 50% from the total waste volume through composting and recycling;
- 8. Conduct information, education and communication campaign for the effective implementation of the activities agreed upon to be undertaken;
- 9. Submit progress reports as well as Financial/Liquidation Reports based on the submitted work and financial plan for the Material Recovery Facility (MRF) projects;

Section 3. Schedule of Reporting:

The SECOND PARTY shall submit progress report based on the approved Work and Financial Plan (WFP) and the corresponding liquidation report on the (status of fund utilization and physical accomplishment);

Section 4. Duration

The Parties agree that the implementation of the activities/ programs for the establishment of the Materials Recovery Facility described under this MOA will be for the Calendar Year 2017.

Section 5. Amendments

By mutual consent, this agreement or part hereof may be modified, repealed, altered, extended, revised, amended or supplemented by the Parties to ensure that the objectives of this agreement is achieved.

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement With the Environmental Management Bureau (EMB) Iloilo, Region VI for the Implementation of the Material Recovery Facilities (MRFs) Project In LGU -Tigbauan, Iloilo,
