RESOLUTION CONFORMING AND APPROVING THE CY 2017 ANNUAL BUDGET, ANNUAL INVESTMENT PLAN, 20% DEVELOPMENT PLAN AND 5% BDRRMF PLAN OF **BARANGAY SUPA**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on February 22, 2017, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2017 Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of Barangay Supa, to wit:

Barangay Supa CY 2017 General Annual Budget Involving an Appropriation of P1,260,864.80, 20% Development Fund in the amount of P250,572.80, and 5% BDRRMF in the amount of P63,043.20 Approved by Sangguniang Barangay on December 19, 2016 and Enacted Under Appropriation Ordinance No. 2016-01;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budget, 20% Development Plan, and 5% BDRRMF Plan which shows apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budget, 20% Development Plan, and 5% BDRRMF Plan of the afore-mentioned barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budget of the above-mentioned barangay shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;

NOW, THEREFORE, on motion of HON. JOHN GERSHWIN C. TUERES, *Vice Chairman, Committee on Appropriations, Budget, Finance, Accounts and Ways & Means (under the sponsorship of HON. DENNIS T. VALENCIA, Committee Chairman)*, and duly seconded by Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Jerry T. Tuares;

RESOLVED, to conform and approve the CY 2017 Annual Budget, Annual Investment Plan, 20% Development Plan and 5% BDRRMF Plan of Barangay Supa, this municipality,
