**Resolution No. 2017-051**

RESOLUTION AUTHORIZING THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (MDRRMO) RESPONDERS ESPECIALLY THE BARANGAY TANODS/RESPONDERS TO BECOME MEMBERS OF THE PHILIPPINE RED CROSS.

WHEREAS, Republic Act 10072 otherwise known as *“An Act Recognizing The Philippine National Red Cross As An Independent, Autonomous, Nongovernmental Organization Auxiliary To The Authorities Of The Republic Of The Philippines In The Humanitarian Field, To Be Known As The Philippine Red Cross”* encourages community members to subscribe to the “membership” of the Philippine Red Cross;

WHEREAS, Section 6 of RA 10072 provides that: *“Sec. 6. Membership. - Membership in the Philippine Red Cross shall be open to the entire population in the Philippines regardless of citizenship. Any contribution to the Philippine Red Cross Annual Fund Campaign shall entitle the contributor to membership for one (1) year and the said contribution shall be deductible in full for taxation purposes.”*

WHEREAS, for the efficient delivery of the services of the MDRRMO, responders especially the Barangay Tanods/Responders to the community are encouraged to be the members of the said organization;

WHEREAS, in return for the membership of these Barangay Tanods/Responders, the Philippine Red Cross undertakes to train them in Disaster Risk Reduction, and the trained members will automatically become *bonafide* Red Cross Disaster volunteers;

WHEREAS, trained members will also be given access to other specialized training reserved for Red Cross Volunteers only;

WHEREAS, any membership fee incurred shall be charged against the MDRRMO fund of the Municipality of Tigbauan;

NOW, THEREFORE, on motion of HON. RONNIE T. PAGUNTALAN, Chairman, Committee on Barangay Affairs and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, and Hon. Jerry Tuares;

RESOLVED, to authorize the Municipal Disaster Risk Reduction Management Office (MDRRMO) Responders Especially the Barangay Tanods/Responders to Become Members of the Philippine Red Cross;

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Philippine Red Cross, to the Office of the Municipal Mayor, Atty. Suzette T. Alquisada and to all concerned for their information and/or appropriate action.
