RESOLUTION CONFORMING AND APPROVING THE CY 2017 SUPPLEMENTAL BUDGET OF BARANGAY **BAROSONG**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 18, 2017 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2017 Supplemental Budget embodying Appropriation Ordinance of Barangay Barosong to wit:

***Brgy. Barosong** Supplemental Budget No. 2017-01 for CY 2017, involving an Appropriation of 45,834.19 and was approved by the Sangguniang Barangay on April 3, 2017.*

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
