RESOLUTION REQUESTING FINANCIAL ASSISTANCE IN THE AMOUNT OF TWENTY FIVE MILLION PESOS (P25,000,000.) FROM CONGRESSWOMAN SHARON S. GARIN, AAMBIS-OWA PARTY LIST REPRESENTATIVE FOR THE REHABILITATION/WIDENING OF MUNICIPAL ROAD IN THE POBLACION, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan is a 2nd class municipality located in the 1st Congressional District, Province of Iloilo with a total population of 62,706 based on the 2015 Census of Population by the Philippine Statistics Authority;

WHEREAS, the Municipality of Tigbauan has a total land area of 8,889 hectares and is composed of 52 Barangays, 10 barangays of which are located in the poblacion area;

WHEREAS, the municipal roads in the poblacion area are already damaged and dilapidated and could no longer accommodate or serve the growing population of residents and the rising number of vehicles;

WHEREAS, these roads under its current condition would only provide difficulty and inconvenience to the riding public; it would also discourage investors and guests/visitors;

WHEREAS, it has been the long desire of the officials of this municipality to undertake the rehabilitation and widening of these municipal roads but its limited resources hinder the same, thus, the need of financial assistance from other concerned agencies and officials;

WHEREAS, the municipal officials are banking their hopes for the realization of this road widening and rehabilitation project on our good Congresswoman, Hon. Sharon S. Garin;
