RESOLUTION RESPECTFULLY URGING REGIONAL DIRECTOR ROLAND C. RAMOS OF THE LAND TRANSPORTATION OFFICE (LTO), REGION VI TO DEPUTIZE AT LEAST TWO (2) PNP PERSONNEL ASSIGNED AT THE TIGBAUAN MUNICIPAL POLICE STATION IN EXIGENCY OF PUBLIC SERVICE

WHEREAS, the Tigbauan Municipal Police Station is seriously campaigning against criminality such as Police Visibility, Patrolling, Barangay Pulong-Pulong and Information Drive aimed at preventing crime incidents;

WHEREAS, this anti-criminality campaign has resulted in the decrease of crime rates in the Municipality, except for cases of Imprudence Resulting to Physical Injuries and Damage to Property mostly due to violations of traffic ordinances and traffic rules and regulations;

WHEREAS, these traffic violations continue because of the lack of authority on the part of the PNP Municipal Police Personnel to implement the same thru the issuance of citation tickets and temporary operators permit (TOP) to violators which falls under the jurisdiction of the Land Transportation Office (LTO), Region VI;

WHEREAS, the deputization by the LTO, Region VI of at least two (2) PNP Personnel assigned at the Tigbauan Municipal Police Station to issue citation tickets and TOP's to traffic violators would greatly help in the implementation of traffic rules to prevent vehicular accidents;

WHEREAS, the said deputization could benefit our constituents as well as the riding public by properly and effectively enforcing the traffic laws, rules and regulations;
