**Resolution No. 2017-071**

RESOLUTION APPROVING THE IDENTIFICATION OF THE CONCRETING OF THE MUNICIPAL ROAD LOCATED AT TEJERO STREET, BARANGAY 9 (POBLACION), TIGBAUAN, ILOILO (*BACK OF THE MUNICIPAL BUILDING*) IN THE AMOUNT OF ONE MILLION NINE HUNDRED NINETY THOUSAND EIGHT HUNDRED SEVENTY FIVE PESOS (P1,990,875.00).

WHEREAS, the Municipality of Tigbauan thru the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada will be implementing projects for the improvement of the Municipal Roads and Bridges;

WHEREAS, it has been observed that there is a need for the rehabilitation of the portion of Tejero Street, specifically the back portion of the Municipal Building;

WHEREAS, during one of the executive meetings, it has been agreed that the rehabilitation of the above-mentioned road shall be given priority and that, the Municipal Engineer prepared the program of works for such project;

WHEREAS, the total amount of the above-mentioned project (*concreting of Tejero St., Barangay 9 (Poblacion), Tigbauan, Iloilo*) is One Million Nine Hundred Ninety Thousand Eight Hundred Seventy Five Pesos (P1,990,875.00) which shall be taken from the allocated budget for the Municipal Roads and Bridges Development Program in the 20% IRA Development Projects for CY 2017 in the amount of Two Million Six Hundred Fifty Thousand Pesos (P2,650,000.00);

WHEREAS, the improved condition of the said road will not only be safe and convenient for road users, but also benefits the whole municipality as one of the major thoroughfares leading to the public market;
