WHEREAS, during his term as Barangay Captain of Namocon, he was recognized as one of the Most Outstanding Barangay Captains in 1979 in the Municipal Level, Provincial Level and up to the Regional level;

WHEREAS, he is considered the most distinguished son of Namocon, a father to the many Cocofed Scholars, a confidant and advisor to the many troubled folks and a dear friend to almost everyone;

WHEREAS, the late Pedro J. Arias died on May 27, 2017 at the age of seventy-seven (77) leaving behind his wife, Era, their children: Ruby, Kenny and Kerby, and their grandchildren to Ruby and Kerby;

WHEREAS, his loss is not only a loss to his family, relatives and friends, but also to his barangay and the town of Tigbauan as well;
