RESOLUTION CONFORMING AND APPROVING THE LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) C.Y. 2017-2019 AND ANNUAL INVESTMENT PROGRAM (AIP) C.Y. 2018 (20% INTERNAL REVENUE ALLOTMENT (IRA) FUND, GENERAL EXPENDITURES (P.S., M.O.O.E., C.O., MDRRM FUND, GAD FUND & OTHER SOURCES)) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipal Development Council of Tigbauan passed Resolution No. 2017-01, approving the Local Development Investment Program (LDIP) C.Y. 2017-2019 and Annual Investment Program (AIP) C.Y. 2018 to be funded out of 20% IRA Fund, General Expenditures Fund (P.S., M.O.O.E., C.O.), MDRRM Fund, GAD Fund and Other Sources;

WHEREAS, the Local Development Investment Program (LDIP) is a basic document linking the local development plan to the budget of the municipality which contains a 3-year prioritized list of programs, projects and activities derived from the Comprehensive Development Plan matched with financing resources of the said municipality;

WHEREAS, Annual Investment Program (AIP) refers to the annual slice of the Local Development Investment Program which constitutes the total resource requirements for all programs, projects and activities like the annual capital expenditures and other operating requirements of the Local Government Unit;

WHEREAS, the 20% Development Fund in the amount of P27,512,052.00 is appropriated as embodied in the 2018 AIP which shall be utilized for programs, projects and activities incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, P7,153,013.00 is appropriated as Municipal Disaster Risk Reduction and Management Fund (MDRRM Fund) embodied in the MDRRM Plan for the Year 2018 which shall be disbursed and utilized strictly pursuant to the provisions of RA 10121 and its implementing rules and regulations;

WHEREAS, P7,153,013.00 as Gender and Development (GAD) Fund is also appropriated as embodied in the CY 2018 GAD Plan which shall be disbursed and utilized strictly pursuant to the provisions of law and its implementing rules and regulations;

WHEREAS, the Local Development Investment Program (LDIP) 2017-2019 and the 2018 Annual Investment Program with pertinent attachments reflect the itemized plans, programs and activities, and were indorsed by the local chief executive for appropriate action;

RESOLVED, to conform and approve the Local Development Investment Program (LDIP) C.Y. 2017-2019 and Annual Investment Program (AIP) C.Y. 2018 (*20% Internal Revenue Allotment (IRA) Fund, General Expenditures (P.S., M.O.O.E., C.O., MDRRM Fund, GAD Fund & Other Sources*)) of the Municipality of Tigbauan, Province of Iloilo;
