RESOLUTION DECLARING AS **LEGAL** AND **VALID** BARANGAY BINALIUAN MENOR ORDINANCE NO. 001 SERIES OF 2016 - *"AN ORDINANCE IMPLEMENTING THE 2016 BARANGAY REVENUE CODE OF BARANGAY BINALIUAN MENOR, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO"*.

WHEREAS, the above-mentioned Barangay Ordinance was referred to this Committee for review and recommendation and the Committee has the following findings, to wit:

The ordinance was accordingly presented in a public hearing and is consistent with the provisions of Section 391 of the Local Government Code, to wit:

"SECTION 391. Powers, Duties and Functions. – (a) The sangguniang barangay, as the legislative body of the barangay, shall:

- (1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law and ordinance and to promote the general welfare of the inhabitants therein;*
- (2) Enact tax and revenue ordinances, subject to the limitations imposed in this Code;*
- (7) Regulate the use of multi-purpose halls, multi-purpose pavements, grains or copra dryers, patios and other post-harvest facilities, Barangay waterworks, Barangay markets, parking areas of other similar facilities constructed with government funds within the jurisdiction of the Barangay and charge reasonable fees for the use thereof;*
- (14) Prescribe fines in amounts not exceeding One Thousand Pesos (P1,000.00) for violation of barangay ordinances;*
- (24) Exercise such other powers and perform such duties and functions as maybe prescribed by law or ordinance*

WHEREAS, the same is also consistent with SECTION 16 of the LGC which provides that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals,

enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma and Hon. Ronnie T. Paguntalan;

RESOLVED, to declare as **Legal** And **Valid** Barangay Binaliuan Menor Ordinance No. 001 Series Of 2016 - *“An Ordinance Implementing The 2016 Barangay Revenue Code Of Barangay Binaliuan Menor, Municipality Of Tigbauan, Province Of Iloilo”*.
