Resolution No. 2017-080

RESOLUTION APPROVING THE IDENTIFICATION OF PROJECTS FOR THE IMPROVEMENT OF THE MUNICIPAL BUILDING (*ADDITIONAL WINGS-BOTH SIDES OF THE MUNICIPAL BUILDING*) TO BE FUNDED FROM THE BUDGET OF THE OFFICE OF THE MAYOR - CAPITAL OUTLAY (*FOR BUILDINGS AND STRUCTURES*) IN THE AMOUNT OF THREE MILLION TWO HUNDRED THOUSAND PESOS (P3,200,000.00).

WHEREAS, the Local Chief Executive in a letter dated June 21, 2017 requested this Sangguniang Bayan for the urgent passing of a *“Resolution Approving the Identification of Projects for the Improvement of the Municipal Building (Additional Wings-Both Sides of the Municipal Building) to be Funded from the Budget of the Office of the Mayor-Capital Outlay for Buildings and Structures in the Amount of Three Million Two Hundred Thousand Pesos (P3,200,000.00)”*;

WHEREAS, during the June 15, 2017 MDC Meeting which was attended by different stakeholders of this municipality, the identification of projects for the improvement of the municipal building (*additional wings-both sides of the municipal building*) to be funded from the 2017 Budget of the Office Of The Mayor - *Capital Outlay (for Buildings and Structures)* in the amount of Three Million Two Hundred Thousand Pesos (P3,200,000.00) was presented and approved pursuant to MDC Resolution No. 2017-03;

WHEREAS, under the 2017 Budget of the Office of the Mayor for Capital Outlay there is a total appropriation of Three Million Eight Hundred Ninety One Thousand Six Hundred Eighty Eight Pesos (P3,891,688.00) intended *for Buildings and Structures*;

WHEREAS, P3,200,000.00 of the said amount (P3,891,688.00) shall be specifically used for the improvement of the Municipal Building (*additional wings for both sides*);

WHEREAS, a **Certification** dated May 31, 2017 was issued by Mrs. Pacita Ledesma, (*Municipal Budget Officer*), Ms. Elma G. Tionsay, (*OIC-Municipal Treasurer*), Mrs. Salvacion Trayfalgar, (*OIC-Municipal Accountant*), and Mr. Jimmy Tupas, (*Municipal Planning and Development Coordinator*) indicating the availability of the amount of P3,200,000.00 for the improvement of the municipal building (*additional wings-both sides of the municipal building*) from the budget of the Office of the Mayor-Capital Outlay (*for Buildings and Structures*);


NOW, THEREFORE, on motion of HON. DENNIS T. VALENCIA, *Chairman, Committee on Appropriations, Budget, Finance, Accounts and Ways & Means* and duly seconded by Hon. John Gershwin Tueres, Hon. Ariel Bernardo, Hon. Hon. Suzette Marie Hilado-Banno, Hon. Neri Camiña, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Julius Ledesma and Hon. Jerry Tuares,

RESOLVED, to approve the Identification of Projects for the Improvement of the Municipal Building (*additional wings-both sides of the municipal building*) to be Funded from the Budget of the Office of the Mayor-Capital Outlay for Buildings and Structures in the Amount of Three Million Two Hundred Thousand Pesos (P3,200,000.00);

RESOLVED FURTHER, to forward a copy of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, Office of the Municipal Budget, Office of the Municipal Accountant, Office of the MPDC and all concerned for their information and/or appropriate action.
