RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) FOR THE OPERATIONS AND MANAGEMENT OF FISHERIES POST-HARVEST FACILITIES IN THE COMMUNITY FISH LANDING CENTER.

WHEREAS, the 1987 Philippine Constitution directs the State to protect the rights of subsistence fishermen, especially of local communities, to the preferential use of communal marine and fishing resources, both inland and offshore and to provide support thereto through appropriate technology and research, adequate financial production, and marketing assistance, and other services;

WHEREAS, Republic Act No. 8550, as amended, otherwise known as the "Philippine Fisheries Code of 1998", authorizes the BFAR to establish post harvest facilities for fishing communities consistent with the policy of providing support to subsistence fisheries in the exercise of their preferential rights to benefit from the country's fisheries resources especially in municipal waters;

WHEREAS, Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandates the LGU to provide its constituents extension facilities related to agriculture and fishery activities which include water and soil resource utilization and conservation projects and enforcement of fishery laws in municipal waters;

WHEREAS, the establishment of fisheries post-harvest infrastructure and facilities, particularly community fish landing centers (CFLCs), is part of the on-going collaboration between the BFAR, Philippine Fisheries Development Authority, and the LGU;

WHEREAS, the parties herein, willfully and jointly agree to extend full support and cooperation for the effective implementation, operation and good governance of the above-mentioned project;

WHEREAS, for and in consideration of the foregoing premises, the PARTIES herein agree and bind themselves to undertake the following:

Roles & Responsibilities of Parties:

A. The BFAR 6 shall:

1. *Procure six (6) units of stand-alone stainless steel fish stalls, one (1) unit upright freezer and one (1) chest type freezer to each Community Fish Landing Center;*
2. *Provide technical support to the LGU to ensure sustainable operation of the project;*
3. *Conduct regular monitoring and evaluation of the project to ensure that the purpose and objectives are attained.*

B. The LGU shall:

1. *Receive the six (6) units of stand-alone stainless steel fish stalls, one (1) unit upright freezer and one (1) unit chest type freezer as fisheries post-harvest facilities component in the Community Fish Landing Center*
2. *Turn-over the fish stalls and freezers to the identified local organized fisherfolk association;*
3. *Assist the local organized fisherfolk association in the operations and management of the fisheries post-harvest facilities in the Community Fish Landing Center;*
4. *Ensure the maintenance, upkeep and sustainable use of the fish stalls and freezers through regular monitoring;*
5. *Submit reports and other relevant data to BFAR 6.*

NOW, THEREFORE, on motion of HON. JERRY T. TUARES, *Chairman, Committee on Agriculture, Aquatic Resources and Cooperatives* and duly seconded by Hon. Dennis T. Valencia, Hon. Ariel I. Bernardo, Hon. John Gershwin C. Tueres, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Ronnie T. Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement (MOA) with the Bureau of Fisheries and Aquatic Resources (BFAR) for the Operations and Management of Fisheries Post-Harvest Facilities in the Community Fish Landing Center;
