RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH JOSE EDGAR GATON OF BARANGAY BUYU-AN, TIGBAUAN, ILOILO FOR THE ELECTRICAL AND WATER SUPPLY OF ALTERNATIVE LEARNING SYSTEM COMMUNITY LEANING CENTER (ALS-CLC)"

WHEREAS, under the Local Government Code of 1991 (RA 7160), the Local Government Units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants. Pursuant to Section 16 of this Code, the municipal mayor shall:

XXX

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Community Learning Center of Brgy. Buyu-an is the seat of the Alternative Learning System (ALS) and the venue of the various trainings and seminars in the Municipality of Tigbauan;

WHEREAS, as convenience strategy, the Municipal Government of Tigbauan requested the assistance of Mr. Edgar Gaton, owner of the house beside the Community Learning Center in Buyu-an to provide electricity to the learning center;

WHEREAS, the Municipality of Tigbauan has appropriated the total amount of Nine hundred Pesos (P900.00) per month for payment of the monthly electrical bill and water supply of the Community Learning Center in Buyu-an, Tigbauan, Iloilo;

WHEREAS, the amount of nine hundred pesos (P900.00) shall be given to Mr. Gaton for a period of ten (10) months for the duration of the project;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement with Jose Edgar Gaton of Barangay Buyu-an, Tigbauan, Iloilo for the Electrical and Water Supply of Alternative Learning System Community Leaning Center (ALS-CLC).

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty.
