RESOLUTION REQUESTING THREE MILLION PESOS (P3,000,000.00) FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT THROUGH HONORABLE ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO FOR THE CONCRETING OF CORDOVA TO OMAMBONG PROVINCIAL ROAD.

WHEREAS, the road connecting Barangay Cordova of the Municipality of Tigbauan and Barangay Omambong of the Municipality of Leon, passing through Barangay Barosong, Tigbauan, is classified as a Provincial Road of the Province of Iloilo;

WHEREAS, the Iloilo Provincial Government conducts regular maintenance works on said Cordova to Omambong Road due to its rough condition, and has implemented partial concreting in the past;

WHEREAS, the implementation of maintenance works and the partial concreting of the road is overwhelmingly appreciated by the inhabitants of the affected barangays as it had provided them comfort and convenience in their daily activities especially in bringing their agricultural produce to the market. Further, such project has also provided safety, promote health and enhance agriculture, economic and livelihood activities;

WHEREAS, despite the regular maintenance works, additional concreting of the said road is still necessary to further address and promote the general welfare of the people; and being permanent and durable, the concreting of the road would require less maintenance works in the future.
