RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DEPED ELEMENTARY AND SECONDARY SCHOOLS FOR THE IMPLEMENTATION/UTILIZATION OF SPECIAL EDUCATION FUND (SEF) IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) EACH

WHEREAS, the Local Government Code provides that the Municipal Mayor shall represent the municipality and enter into contracts for and in behalf thereof, only upon authority given by the Sangguniang Bayan;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

X X X

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Local School Board has approved in its 2017 Budget that each school in the whole Municipality of Tigbauan shall be appropriated the amount of P50,000 each for its repair/maintenance and/or purchase of equipment necessary for the improvement of the learning process of the students;

WHEREAS, there is a need for the LGU of Tigbauan to enter into a MOA with the different schools for the implementation of the said projects;

NOW THEREFORE, on motion of HON. MA. GERRYLIN SANTUYO-CAMPOSAGRADO, *Chairperson, Committee on Education and Civil Service* and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, and Hon. Jerry T. Tuares;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tibbauan to enter into a memorandum of agreement with DEPED Elementary and Secondary Schools for the implementation/utilization of Special Education Fund (SEF) Projects in the amount of Fifty Thousand Pesos (P50,000.00) each,
