RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A DEED OF DONATION WITH THE BUREAU OF FIRE PROTECTION, TIGBAUAN FIRE STATION FOR THE DONATION OF A PORTION OF LOT NO. 926-B LOCATED AT BARANGAY NAMOCON, TIGBAUAN, ILOILO WITH AN AREA OF FIVE HUNDRED (500) SQUARE METERS AND TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO TRANSFER TITLE TO THE DONATED LOT IN THE NAME OF BFP TIGBAUAN FIRE STATION

WHEREAS, in line with the *Bureau of Fire Protection (BFP) modernization program*, the National Government through the Department of Interior and Local Government (DILG) has launched its Program to finance the construction of a typical Fire Station building with a brand new fire truck for Local Government Units (LGUs) once it could provide a parcel of land as site thereof with a minimum area of five hundred (500) square meters more or less;

WHEREAS, the municipal officials of the LGU Tigbauan, Iloilo recognize the importance and necessity of availing such project pursuant to its mission and vision of becoming a First Class Municipality;

WHEREAS, on May 13, 2015, Supt. Jose Filomeno E. Salolog, Jr., *Provincial Fire Marshall, Bureau of Fire Protection, Regional Office VI, Iloilo Provincial Office* issued a Memorandum to All CFM's and MFM's with the Subject: *"Requirement of Lot Donation for the Establishment of Typical Fire Station Nationwide"* which provides, among others, that the Fire Station site shall be in the name of the BFP-Tigbauan Fire Station;

WHEREAS, LGU Tigbauan has an available lot as site for this project consisting of a 500 square meter-portion of Lot No. 926-B located at Barangay Namocon which it acquired from Paz Zayco and presently declared under Tax Declaration No. 1086;

WHEREAS, on October 3, 2017, pursuant to the said BFP Memorandum, the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, requested this August Body for the passage of a “*Resolution Authorizing the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to enter into a Deed of Donation (500 square meter lot) with the Bureau of Fire Protection, Tigbauan Fire Station, and Sign Other Related Documents Necessary for the Transfer of Title.*”

WHEREAS, there is a need for the Sangguniang Bayan of Tigbauan to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in Behalf of the Municipality of Tigbauan, to execute and sign a Deed of Donation in favor of the BFP-Tigbauan Fire Station over said project site;

WHEREAS, with the execution of the Deed of Donation and submission of other required documents, the Officials of LGU-Tigbauan firmly believe that this municipality could avail of the BFP modernization program, *the construction of a typical BFP building with a brand new fire truck*;

NOW THEREFORE, on motion of HON. NERI T. CAMIÑA, *Chairman, Committee on Peace and Order & Public Safety* and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado and Hon. Jerry T. Tuares;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada for and in behalf of the Municipality of Tigbauan to Enter Into A Deed Of Donation with the Bureau of Fire Protection, Tigbauan Fire Station for the Donation of a Portion of Lot No. 926-B located at Barangay Namocon, Tigbauan, Iloilo with an area of Five Hundred (500) Square Meters and to Sign any and all necessary documents to Transfer Title to the Donated lot in the name of BFP Tigbauan Fire Station,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, and to all concerned for their information and guidance.
