RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR DEFENSOR, SR. GOVERNOR, PROVINCE OF ILOILO IN THE AMOUNT OF SIX HUNDRED THOUSAND PESOS (P600,000.00) FOR THE RENOVATION OF THE ROOFING OF THE TIGBAUAN PUBLIC MARKET, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 62,706 inhabitants as of 2016;

WHEREAS, the Municipality of Tigbauan has a rapid expanding population and it badly needs an improved and spacious market for its populace;

WHEREAS, the Tigbauan Public Market was constructed way back in 1950s and some portions of it is now dilapidated especially the roofings (*along Tejero St. at the back of the new building*);

WHEREAS, because of the bad condition of that portion, it was decided by the Chairman, Committee on Market and Slaughterhouse to request financial assistance from the good Governor;

Zenny Rose Tavarra (counterpart of Hon. Ma. Gerrylin Santuyo-Camposagrado), Hon. Kiara Tamayo (counterpart of Hon. Jerry Tuares) and Hon. Irene Jean Tidula (counterpart of Hon. Ronnie Paguntalan);
