### **Resolution No. 2017-123**

RESOLUTION CONFORMING AND APPROVING THE CY 2017 SUPPLEMENTAL BUDGET OF BARANGAY **BITAS**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on October 19, 2017 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2017 Supplemental Budget embodying Appropriation Ordinance of the following barangay:

**Brgy. Bitas** Supplemental Budget No. 2017-001 for CY 2017, involving an Appropriation of 159,549.97 and was approved by the Sangguniang Barangay on September 15, 2017.

WHEREAS, the review of the Supplemental Budget embodying Appropriation Ordinance for CY 2017 of the aforementioned Barangay likewise shows apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the utilization of the Supplemental Budget shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
