### **Resolution No. 2017-126**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE GAWAD KALINGA COMMUNITY DEVELOPMENT FOUNDATION, INC. FOR THE GAWAD KALINGA PROGRAM

WHEREAS, Gawad Kalinga is a community development foundation which undertakes the role of building communities for the poor as its primary objective to become a catalyst in uplifting the quality of life thru community organizing, shelter, health, education, environment and livelihood geared towards an integrated, holistic and sustainable development;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

*SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.*

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:*

x x x

*(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;*

WHEREAS, the Municipality of Tigbauan is interested to adopt the Gawad Kalinga Program as part of its commitment to uphold genuine and responsive public service, and mission towards social transformation;

WHEREAS, for and in consideration of the foregoing premises, Gawad Kalinga Community Development Foundation Inc. and the Municipality of Tigbauan agree to be bound by the following terms and conditions:

**ARTICLE I**  
**RESPONSIBILITIES OF THE PARTIES**

**Section 1: Roles and Functions of Gawad Kalinga:**

**Under this Agreement, Gawad Kalinga Community Development Foundation Inc. commits to:**

- 1.1 Provide proper orientation and training for volunteers of the college/university to introduce and implement the Barangay Walang Iwanan Campaign (BWI);
- 1.2 Identify & match the school/university to a Gawad Kalinga Community/Brgy. Community where they can implement the BWI program/projects, research and deploy students for community immersion;
- 1.3 Organize and implement Gawad Kalinga Youth as a youth productivity program that aims to facilitate outreach programs for various youth organizations of the barangay itself;
- 1.4 Organize and implement Gawad Kalinga Builders as capacity development program for all the Volunteers of the Municipality that aims to deepen their understanding in community involvement and help them facilitate outreach programs for other community volunteers or the barangay itself;
- 1.5 Identify opportunities for research and community immersion activities for the volunteers, workers and LGU staff;
- 1.6 Monitoring and evaluation of volunteers performance when such an evaluation is required;
- 1.7 Make available resource materials (i.e. audio-visual materials, publications, conference results, etc.) that will help teaching-learning relative to social awareness and transformation;
- 1.8 Share the Gawad Kalinga way of building capacities to empower communities and achieve sustainable transformation.

**Section 2: Roles and Functions of Municipality:**

**Under this Agreement the Municipality of Tigbauan commits to:**

- 2.1 To spearhead the formation of Barangay Walang Iwanan Volunteer HUB which is composed of representatives from the different sectors of the Municipality;
- 2.2 Assists the BWI Hub in planning and doing activities in the Barangay aligned with the programs of the LGU;
- 2.3. Assist Gawad Kalinga by disseminating the content and consolidating basic information of the barangay through Data Mapping;
- 2.4. Monitor all BWI activities within the Municipality;
- 2.5. Serve as venue for training and empowerment of volunteers and take on the role of nation building;
- 2.6. Inspire, stimulate and sustain the growth and capacities of the members and volunteers of the hub;
- 2.7. Conduct ocular visit within the barangay and engage as catalyst of the BWI programs to the key leaders of the barangay;
- 2.8. Allow the Gawad Kalinga Youth and/or the Gawad Kalinga Builder help organize outreach activities within the barangay;
- 2.9. Develop learning materials based on the Gawad Kalinga experience through community-based research and development and make available their research finding to the larger Gawad Kalinga network through seminars, classes and other forms of teaching;
- 2.10. Provide official and institutional support to representatives and volunteers of the municipality to major Gawad Kalinga undertakings and events (collaborative research, symposia, conferences, trainings, etc.); and
- 2.11. Engage partnership with other stakeholders.

**ARTICLE 2**

The agreement may be amended and modified from time to time, upon mutual agreement of the parties in writing duly signed and acknowledged, which amendment or modification shall be attached, forming an integral part of the original instrument.

**ARTICLE 3**

The Volunteer shall indemnify and hold the Municipality of Tigbauan and Gawad Kalinga free and harmless from any claim, suit, damage or liability arising out of, or resulting from their failure to exercise due diligence or perform their work in accordance with the rules and regulations relating to safety and protection of workers./interns or practicums and the terms of this understanding.

John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuarez and Hon. Ronnie T. Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan, to enter into a Memorandum of Agreement with the Gawad Kalinga Community Development Foundation, Inc. for the Gawad Kalinga Program,

RESOLVED FURTHER, to forward a copy of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, to the Gawad Kalinga Community Development Foundation, Inc. and all concerned for their information and/or appropriate action.
