RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRAANCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ST. NICHOLAS TRAINING INSTITUTE INCORPORATED FOR THE IMPLEMENTATION OF THE UNIMPLEMENTED BUB-DTI PROJECTS 2015.

WHEREAS, LGU-Tigbauan is a recipient of BUB-DTI Funds of Three Million One Hundred Thousand Pesos (P3,100,000.00) received in December 11, 2015;

WHEREAS, a Memorandum of Agreement (MOA) signed in November 05, 2015 stated in Paragraph 7 that LGU-Tigbauan has approved projects which are included in DTI's Budget for 2015 as follows:

1. Rural Micro-Enterprise Dev't Program	Php. 1,000,000.00
2. Livelihood Yamang Pinoy	Php. 1,500,000.00
3. OTOP Store Express/Pasalubong Center	Php. 600,000.00

WHEREAS, Paragraph 9, p.2 of the same Memorandum of Agreement states the Responsibilities of both parties. Partner LGU being the Municipality of Tigbauan will (*No. 4 Responsibilities of Partner LGU*) receive funds and ensure the prompt implementation of the project in accordance with approved plans and Program of Works;

WHEREAS, for unimplemented projects, according to Dir. Jerry T. Clavesillas, DTI Memorandum dated August 3, 2017, all projects should have been completed within validity period of two (2) years (*December 2017*);

WHEREAS, as of date, we have remaining projects to conduct. Bidding and delivery of needed supplies and materials are complied and ready for the following trainings:

LGU-Tigbauan as the implementing LGU will have to pay the St. Nicholas Training Institute Incorporated upon compliance and completion of the services for the amount due stated in the Contract of Service from the trust fund BUB-DTI as follows:
