RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA- ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN A DEED OF DONATION IN FAVOR OF THE DEPARTMENT OF EDUCATION/BAGACAY NATIONAL HIGH SCHOOL OF A PORTION OF LOT 18526, PSC-49 CONSISTING OF TEN THOUSAND SQUARE METERS COVERED BY TCT NO. 090-2017009058 LOCATED IN BRGY. BAGACAY, TIGBAUAN, ILOILO.

WHEREAS, because of the growing population of students from Brgy. Bagacay and its surrounding barangays, the Tigbauan National High School extension was established in 2012;

WHEREAS, to provide an area on which to build the said school, the Local Government Unit of Tigbauan, through the then Mayor Excelsior M. Torres, purchased Lot No. 18526, PSC-49;

WHREAS, Lot No. 18526, PSC-49 is now titled in the name of the Municipality of Tigbauan, under TCT No. 090-2017009058, containing a total area of 15,205 square meters, more or less;

WHREAS, the faculty, staff and PTA Officers of Bagacay National High School are requesting the LGU Tigbauan, Iloilo that the lot occupied by their school be donated to them for their exclusive use and improvement;

WHEREAS, the LGU Tigbauan, through Legislative-Executive Agreement has decided to donate and grant full ownership to Bagacay National High School the total area of 10,000 sq. m. and allowing the temporary use and administration over the remaining area of 5,205 sq.m. while reserving ownership thereof for future needs of the LGU;


NOW, THEREFORE, upon motion of Hon. Ma.Gerrylin Santuyo-Camposagrado, Chairman, Committee On Education and Civil Service, and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Julius T. Ledesma and Hon. Jerry T. Tuares,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED. to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the municipality, to sign a Deed of Donation in favor of the Department of Education/Bagacay National High School over a portion of lot 18526, Psc-49 consisting of Ten Thousand (10,000) square meters more or less, covered by TCT No. 090-2017009058 located in Brgy. Bagacay, Tigbauan, Iloilo

RESOLVED FURTHER, to furnish copies of this Resolution to Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, to Bagacay National High School, Tigbauan, Iloilo, to the Department of Education, Division of Iloilo and all concerned for their information and/or appropriate action.
