RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DR. MERLINDA TUCAR AND MR. NICK JOHN SOLAR FOR THE IMPLEMENTATION OF VARIOUS TRAININGS UNDER THE GENDER AND DEVELOPMENT- SMALL AND MEDIUM ENTERPRISE DEVELOPMENT (GAD – SMED) PROGRAM OF THE MUNICIPALITY OF TIGBAUAN

WHEREAS, LGU-Tigbauan has an available fund from 5% GAD-SMED to pay for the honorarium of qualified resource persons to handle skills training and workshops on Product Development & Enhancement Training on rice based delicacies, Product Branding, Promotion and Market Matching, Business and Financial Management, Juices and Chew, Packaging and Labeling, Entrepreneurship, as well as Crafts out of Tigbaw;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, a total of Thirty-Eight Thousand Eight Hundred Pesos (Php 38,800.00) is allocated to pay identified Resource Persons for the above mentioned trainings with Gender and Entrepreneurship Together (GET) Orientation;

WHEREAS, after thorough process of identifying the most qualified resource persons we have decided to invite our experienced resource persons from Barangay Buyu-an, Dr. Merlinda T. Tucar with Mr. Nick John Solar to do the job of giving their professional talents and expertise to our clients/participants to be trained as follows:
