Resolution No. 2017-133

RESOLUTION REGULATING THE CONDUCT OF SPORTS PROGRAMS AND ACTIVITIES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, it is a declared policy of the municipality to promote and strengthen the sports for all programs and encourage total involvement and participation of every individual/sector of the community in sports programs and activities;

WHEREAS, Section 19 of the 1987 Constitution states that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork and excellence for the development of a healthy and alert citizenry;

WHEREAS, Executive Order No. 035, Series of 2017 mandates the organization of the Municipal Sports Council, a management structure that will be responsible for regulating the conduct of various sports programs and activities in the municipality;

WHEREAS, by virtue of the powers vested by the Local Chief Executive and as Chairman of the Municipal Sports Council, the regulation of the conduct of sports programs and activities in the Municipality of Tigbauan is hereby ordered, to wit:

1. Any barangay, school, NGO, CSO or any private organization or entity that plans to conduct sports activities shall submit activity design or proposal to the Municipal Sports Council;
2. All sports programs and activities in the municipality shall be submitted to the Council for review and approval;
3. The Council shall determine the appropriate guideline for every sports activity conducted including the rates and honorarium of the sports officials on duty;
4. The proponent of the sports activity shall ensure that the officials are trained, expert and competent;

- 5. The promoter of the sports program shall ensure safety and security of the athletes and officials during each and every activity undertaken;
- 6. The barangay, school, sports club or organization shall ensure that the activity will run smoothly and any negative outcome shall be avoided; otherwise, the entity shall not be permitted to hold again any kind of sports activity;
- 7. Different sports clubs or sports organizations shall be recognized by the Sangguniang Bayan, Committee on Youth and Sports Development;
- 8. The Municipal Sports Council shall meet every last Friday of the month to discuss sports-related topics, issues and concerns in the municipality.

RESOLVED, to regulate the conduct of sports programs and activities in the Municipality of Tigbauan, Province of Iloilo,
