RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2017-04 – “RESOLUTION APPEALING TO THE OFFICE OF THE MUNICIPAL ENGINEER, THE BIDS AND AWARDS COMMITTEE AND ALL CONCERNED OFFICES TO FAST-TRACK THE IMPLEMENTATION OF PRIORITY PROJECTS UNDER THE 20% INTERNAL REVENUE ALLOTMENT DEVELOPMENT FUND FOR FY 2017”.

WHEREAS, pursuant to the provision of the RA 7160 or the Local Government Code of 1991, the Local Government has jurisdiction over all programs and projects designated for the promotion and general welfare of its constituents;

WHEREAS, these basic services include infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school buildings and other facilities for public elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply systems; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities;

WHEREAS, based on the recent Seal of Good Local Governance (SGLG) Evaluation, it was discovered by the Department of Interior and Local Government (DILG) that several priority projects for CY 2017 - 20% IRA Development Fund were not yet implemented;

WHEREAS, these projects under this Development Fund need immediate implementation;

WHEREAS, the following projects were identified by the members of the Municipal Development Council to be the top priorities to be implemented for the year 2017, to wit:
