**Resolution No. 2017-144**

RESOLUTION CONFORMING AND APPROVING THE CY 2017 SUPPLEMENTAL BUDGET OF BARANGAYS 2 (POBLACION) AND 3 (POBLACION), THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on December 6, 2017 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2017 Supplemental Budget embodying Appropriation Ordinance of the following barangays:

**Brgy. 2 (Poblacion)** Supplemental Budget No. 2017-001 for CY 2017, involving an Appropriation of P25,947.15 and was approved by the Sangguniang Barangay on December 2, 2017.

**Brgy. 3 (Poblacion)** Supplemental Budget No. 2017-001 for CY 2017, involving an Appropriation of P68,661.23 and was approved by the Sangguniang Barangay on November 20, 2017.

WHEREAS, the review of the Supplemental Budgets embodying Appropriation Ordinances for CY 2017 of the aforementioned Barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned Barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
