RESOLUTION CONFORMING AND APPROVING THE CY 2018 ANNUAL BUDGETS, ANNUAL INVESTMENT PLANS, 20% DEVELOPMENT PLANS AND 5% BDRRMF PLANS OF **BARANGAYS 7 (POBLACION) AND 4 (POBLACION)**, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 12 and 17, 2018, endorsed to the Office of the Honorable Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2018 Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the following barangays:

Barangay 7 (Poblacion) CY 2018 General Annual Budget Involving an Appropriation of **P1,901,875.00**, 20% Development Fund in the amount of **P370,975.00**, and 5% BDRRMF in the amount of **P95,093.75** Approved by Sangguniang Barangay on December 4, 2017 and Enacted Under Appropriation Ordinance No. 2017-02;

Barangay 4 (Poblacion) CY 2018 General Annual Budget Involving an Appropriation of **P1,625,316.00** and 20% Development Fund in the amount of **P320,803.20**, and 5% BDRRMF in the amount of **P81,265.80** Approved by Sangguniang Barangay on November 10, 2017 and Enacted Under Appropriation Ordinance No. 2017-003;

WHEREAS, the Municipal Budget Officer had reviewed the said Barangay Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans which shows apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, and 5% BDRRMF Plans of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation of the Annual Budgets of the above-mentioned barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Annual Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the sole responsibility of the officials of the implementing local government unit;
