Resolution No. 2018-025

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRENCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL NUTRITION COUNCIL FOR THE IMPLEMENTATION OF DIETARY SUPPLEMENTATION PROGRAM (DSP) FOR PREGNANT WOMEN

WHEREAS, a Memorandum of Agreement (MOA) was executed on April 20, 2017 by and between NNC and the Municipality of Tigbauan, which among others, provided for the transfer of funds to the Municipality of Tigbauan for the activities related to Early Childhood Care and Development in the First 1000 Days (ECCD F1K) Program;

WHEREAS, additional funds should be transferred to respond to emerging needs of the Municipality of Tigbauan;

WHEREAS, for and in consideration of the foregoing premises, the parties, hereto have agreed to the following terms and conditions:

Section 1. Purpose of the Supplemental MOA

The Supplemental Memorandum of Agreement (MOA) aims to provide additional funding support to the Municipality of Tigbauan for the conduct of “**Dietary Supplementation Program (DSP) for Pregnant Women**” in the amount of Php 4,662,247.00 for 2017. Such will be additional activities for the implementation of Early Childhood Care and Development in the First 1000 Days.

Section 2. Responsibilities of the Parties

Section 2.1 The NNC shall:

1. Provide funding support for the conduct of DSP;
2. Provide guidelines for the implementation of the program;
3. Release funds in accordance to the approved Supplemental Work and Financial Plan and;
4. Lead in the monitoring activities fund utilization;

Section 2.2 The Municipal LGU shall:

1. Ensure the conduct of orientation and social preparation activities at the municipal and barangay level for the implementation of DSP;
2. Follow the technical guidelines to be provided by the NNC for the conduct of DSP;
3. Strictly follow the rules provided in the revised IRR of RA 9184 or the ***“Government Procurement Reform Act.”***
4. Deposit the funds received from NNC to the existing Trust Fund account maintained at Authorized Government Depository Bank (AGDB);
5. Issue Official Receipt in acknowledgement of funds received;
6. Disburse the funds strictly in accordance with the Supplemental Work and Financial Plan and to the existing government accounting and auditing rules and regulations;
7. Return or refund to NNC any unused balance of funds upon completion of the activity. Unless a request for reprogramming of said balance is submitted to NNC and issued with approval, unused balance shall be reprogrammed to ECCD F1K related activities;
8. Upon completion of the activities, submit liquidation reports as required under COA Circular No. 94-013 dated 13 December 1994. Subsequent release of funds intended for the same purpose shall be made only upon full liquidation and submission of COA audited reports which is the basis for liquidation of funds released and;
9. Submit reports as required by the program's monitoring and evaluation system and participate in the monitoring activities.

Section 3. Additional Funding Support Provided by the NNC

Additional funding support as indicated in the attached work and financial plan shall be used as intended and in accordance with government rules and regulations. Any additional cost not indicated in the guidelines, that will be incurred from the conduct of DSP shall be charged to the LGU.


NOW, THEREFORE, on motion of Hon. Julius T. Ledesma, Committee Vice Chairman, (under the sponsorship of Hon. Suzette Marie Hilado-Banno, Chairperson, Committee on Women, Family, Social Services and Senior Citizens) and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Ma. Gerrylin Santuyo-Camposagrado, and Hon. Jerry Tueres,

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, for and in behalf of the Municipality of Tigbauan to enter into a Memorandum of Agreement with the National Nutrition Council for the Implementation of Dietary Supplementation Program (DSP) for Pregnant Women,

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada and to all concerned to their information and/or appropriate action.
