WHEREAS, there is only one candidate for the said position Municipal Civil Registrar, despite publication with the Civil Service Commission ERPO (Examination, Recruitment, and Placement Office) Manila for the existence of the vacancy for the position;

WHEREAS, after the interview and deliberation, there was a unanimous decision among the members of the HRMPSB to recommend the promotion of Mrs. Mary Anne T. Pascual who is occupying the position of Registration Officer I which is a next-in-rank position to Municipal Government Department Head (*Municipal Civil Registrar*),

WHEREAS, Ms. Mary Anne T. Pascual was able to meet the minimum requirements for qualification to the position provided in Republic Act 7160 or The Local Government Code of the Philippines, to wit: "No person shall be appointed civil registrar unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, a holder of a college degree from a recognized college or university, and a first level civil service eligible or its equivalent. He must have acquired experience in civil registry work for at least five (5) years in the case of the city civil registrar and three (3) years in the case of the municipal civil registrar. The appointment of a civil registrar shall be mandatory for city and municipal governments".
