RESOLUTION REQUESTING THE ILOILO PROVINCIAL LEGAL OFFICE TO REPRESENT THE MUNICIPALITY OF TIGBAUAN IN SPECIAL CIVIL ACTION NO. 56 ENTITLED *“EAGLE CREST GAMING AND HOLDING CORPORATION VS. THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, REPRESENTED BY VICE MAYOR, HON. VIRGILIO TERUEL”*.

WHEREAS, on October 25, 2017 the Sangguniang Bayan of Tigbauan passed Municipal Ordinance No. 2017-017 entitled *“An Ordinance Regulating Certain Acts of STL Authorized Agent Corporation (AAC), its Sales Representatives and Supervisors and the Betting Public in the Municipality of Tigbauan and Providing Penalties or Sanctions for Violation Thereof”*;

WHEREAS, on November 28, 2017 said Ordinance was approved and declared as legal and valid by the Sangguniang Panlalawigan, Province of Iloilo;

WHEREAS, Special Civil Action No. 56 for Declaratory Relief with Prayer for Issuance of Temporary Restraining Order (TRO) and/or Preliminary Injunction was filed by Eagle Crest Gaming and Holding Corporation against the Sangguniang Bayan of Tigbauan before the Regional Trial Court, Branch 67, Guimbal, Iloilo seeking to enjoin the implementation of Municipal Ordinance No. 2017-017;

WHEREAS, the Municipality, or the Sangguniang Bayan, in the absence of a Municipal Legal Officer, may ask assistance from the Provincial Legal Office within the context of Section 31, Local Government Code of 1991;
