## Resolution No. 2018-036

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA AND OIC-MUNICIPAL TREASURER, MISS ELMA G. TIONSAY, TO OPEN A BANK ACCOUNT WITH LANDBANK OF THE PHILIPPINES (LBP) FOR THE IMPLEMENTATION OF PHILHEALTH'S AUTO-CREDIT PAYMENT SCHEME (ACPS) TO ALL HEALTH CARE INSTITUTIONS (HCI).

WHEREAS, Philhealth Circular No. 043 series 2012 entitled "Reimbursement of Hospital Claims through Auto-Credit Payment Scheme (ACPS)" became a pivotal component in shortening the claims processing time thereby improving claims processing efficiency;

WHEREAS, ACPS is a mechanism whereby payment of the claims of health care institutions (HCIs) is credited directly through its designated deposit account with the partner bank/s;

WHEREAS, although participation in ACPS was offered only to hospitals, and on an optional basis, the remarkable experience gained from this process by both Health Care Institutions (HCIs) and Philhealth has been encouraging enough for the latter to consider strengthening its application through a wider involvement of HCIs;

WHEREAS, this policy aims to improve claim process efficiency by automating Philhealth's payment mechanism with the HCIs banking service providers and also guide HCIs by prescribing standard requirements for HCI auto-credit registration, official receipt information, and auto-credit payment schedules;

WHEREAS, the expanded ACPS shall cover all claims coming from HCIs but this ACPS shall not apply to member-filed claims;

NOW, THEREFORE, on motion of HON. SUZETTE MARIE HILADO-BANNO, Chairperson, Committee on Health and Sanitation and duly seconded by Hon. Dennis T. Valencia, Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Jerry T. Tuares and Hon. RonnieT.Paguntalan;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada and OIC-Municipal Treasurer, Miss Elma G. Tionsay, to Open a Bank Account with Landbank of the Philippines (LBP) for the Implementation of Philhealth's Auto-Credit Payment Scheme (ACPS) to All Health Care Institutions (HCI);
