RESOLUTION THANKING AND RECOGNIZING THE EFFORTS OF OVERSEAS WORKERS WELFARE ADMINISTRATION (OWWA), ESPECIALLY TO ADMINISTRATOR HANS LEO CACDAC AND AKSYON RADYO ILOILO IN HELPING AND FACILITATING FOR THE RESCUE AND REPATRIATION OF OVERSEAS FILIPINO WORKER (OFW) JONA TAGHAP TEVES AT RIYADH, SAUDI ARABIA FROM THE HANDS OF HER CRUEL EMPLOYER

WHEREAS, Mrs. Jona Taghap Teves, 30 years old and a resident of Brgy. Napnapan Norte, Tigbauan, Iloilo is a mother of four minor children, who ventured to work as domestic helper in Riyadh, Saudi Arabia last February 2017 due to poverty;

WHEREAS, unfortunately, Jona is among the many OFW's who worked as a domestic helper in the Middle East Countries; that instead of finding heaven, Mrs. Jona Taghap Teves encountered suffering and agony in the hands of her employer;

WHEREAS, last January 31, 2018, Jona contacted her family and begged to do something for her immediate repatriation. Jona was not paid of her salaries, was forced to work and was not given enough foods;

WHEREAS, the family sought the help of Aksyon Radyo Iloilo headed by Station Manager John Paul Tia who facilitated and made follow-ups to concerned government agencies;

WHEREAS, the efforts to rescue OFW Jona from her cruel employers turned fruitful and resulted to her immediate repatriation;

WHEREAS, the Local Government Unit of Tigbauan, headed by Mayor Atty. Suzette Alquisada is thankful to the efforts made by agencies and entities like the OWWA and Aksyon Radyo, Iloilo who helped and facilitated for the rescue and repatriation of distressed OFW Jona Taghap Teves;
