RESOLUTION GRANTING THE REQUEST OF THE COUNCIL OF BRGY. 6, POBLACION TO PUT UP TEMPORARY RUBBER HUMPS, PROVIDED WITH PROPER SIGNAGES TO CAUTION THE DRIVER OF THE VEHICLES PLYING ALONG LEONARDIA STREET, TIGBAUAN, ILOILO

WHEREAS, the Leonardia Street at Brgy. 6, Poblacion, Tigbauan, Iloilo is thickly populated;

WHEREAS, the said street needs to put up temporary rubber humps to minimize the speed of vehicles passing thereby;
