RESOLUTION CONFORMING AND APPROVING THE CY 2018 SUPPLEMENTAL BUDGET OF BARANGAY LANAG, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 7, 2018 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2018 Supplemental Budget embodying Appropriation Ordinance of the following barangay:
