RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRENCIA-ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF SERVICES FOR THE ENGAGEMENT OF THE SERVICES OF ENGR. JOUBERT L. TORRENTO AS ENGINEER

WHEREAS, the Local Government Unit (LGU) of Tigbauan is in need of the services of a qualified engineer to perform work in the Municipal Engineering Office so as to facilitate the efficient implementation of various programs, projects and activities and other developmental projects of the Local Government Unit;

WHEREAS, ENGR. JOUBERT L. TORRENTO possesses the qualification, skill and expertise, and signified his intention to continue his service;

WHEREAS, ENGR. JOUBERT L. TORRENTO possesses the education, experience and skills required to perform the job as described in the contract and he attests that he is not related within the third degree of consanguinity or affinity to the hiring authority and/or representative of the LGU, and also has not been previously dismissed from government service by reason of an administrative offense;

WHEREAS, ENGR. JOUBERT L. TORRENTO shall hereby be contracted as Job Order Personnel – Engineer II in consideration of the daily rate of P1,000.00 to be paid on a daily basis;

WHEREAS, it is understood that this contract does not create an employer and employee relationship between the LGU and ENGR. JOUBERT L. TORRENTO, and the services rendered as stated in the contract are not considered as bases for entitlements to leave privileges and other benefits enjoyed by the regular personnel of the LGU, such as but not limited to PERA, ACA and RATA;

WHEREAS, notwithstanding the fixed duration of the contract, the services of ENGR. JOUBERT L. TORRENTO may be terminated earlier than the expiration date due to unsatisfactory service, unavailability of funds, early completion or discontinuance of the project, or other reasons within the control of ENGR. JOUBERT L. TORRENTO;
