RESOLUTION CONFORMING AND APPROVING THE CY 2018 SUPPLEMENTAL BUDGETS OF BARANGAYS BINALIUAN MAYOR, PARARA NORTE AND JAMOG, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on March 27, 2018 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the attached CY 2018 Supplemental Budgets embodying Appropriation Ordinances of the following barangays:

Brgy. Binaliuang Mayor Supplemental Budget No. 2018-001 for CY 2018, involving an Appropriation of P195,534.15 and was approved by the Sangguniang Barangay on March 4, 2018.

Brgy. Parara Norte Supplemental Budget No. 2018-001 for CY 2018, involving an Appropriation of P250,000.00 and was approved by the Sangguniang Barangay on March 5, 2018.

Brgy. Jamog Supplemental Budget No. 2018-001 for CY 2018, involving an Appropriation of P60,500.00 and was approved by the Sangguniang Barangay on March 19, 2018.

WHEREAS, the review of the Supplemental Budgets embodying Appropriation Ordinances for CY 2018 of the aforementioned Barangays likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, the appropriation for the Supplemental Budgets of the above-mentioned Barangays shall be utilized for expenses and projects incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, the utilization of the Supplemental Budgets shall be in accordance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
