RESOLUTION COMMENDING MR. RADDY CUBIL, PEDICAB DRIVER, AND MS. MARY ANN B. SEARES, LGU EMPLOYEE, FOR THE EXEMPLARY DISPLAY OF HONESTY FOR TURNING OVER TO TIGBAUAN MUNICIPAL POLICE STATION ONE (1) BLACK WALLET CONTAINING CASH, CREDIT CARDS AND OTHER IMPORTANT DOCUMENTS OWNED BY MR. CRAIG ALAN NITSCHKE, AN AMERICAN CITIZEN, TEMPORARILY RESIDING AT BRGY. NAMOCON, TIGBAUAN, ILOILO.

WHEREAS, **Mr. Raddy Cubil**, a pedicab driver, a resident of Brgy. 6, Tigbauan, Iloilo and **Mary Ann B. Seares**, an employee of Tigbauan LGU, personally turned over to Tigbauan Municipal Police Station One (1) black wallet containing the following items: cash in different Philippine Peso denominations in the sum of Five-Thousand Five-Hundred Pesos (PhP 5,500.00), cash in different US Dollar denominations in the total amount of Fifty US Dollars (USD50.00); Visa Card, Master Card (Debit Card) and US Government Identification Card;

WHEREAS, both of them alleged that they found the said wallet in a highway at Brgy. 7, Tigbauan, Iloilo dated April 6, 2018 at 01:40 PM;

WHEREAS, later, that evening at 9:00, the Tigbauan MPS, turned over all the above mentioned items to Mr. Craig Alan Nitschke, of legal age, an American National, temporarily residing at Brgy Namocon, Tigbauan, Iloilo with contact number 511-92-21 after he positively identified the above said items and it was identified that he was indeed the legitimate owner;
