RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP), 20% INTERNAL REVENUE ALLOTMENT (IRA) FUND, GENERAL EXPENDITURES (P.S., M.O.O.E., C.O., 5% MDRRM FUND, 5% GAD FUND & OTHER SOURCES) FOR CY 2019 OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Annual Investment Program (AIP) was approved by the Municipal Development Council (MDC) on its March 26, 2018 meeting per Resolution No. 2018-04 entitled, *"Resolution Approving the Annual Investment Program (AIP), 20% Internal Revenue Allotment (IRA) Fund, General Expenditures (P.S., M.O.O.E., C.O., 5% MDRRM Fund, 5% GAD Fund & Other Sources) for CY 2019 of the Municipality of Tigbauan, Province of Iloilo"*;

WHEREAS, during the meeting, members of the Local Finance Committee (LFC), department heads, Punong Barangays, representatives from the CSOs and other stakeholders, the Municipal Mayor, and Sangguniang Bayan Members thoroughly discussed the proposed programs, projects and activities, and identified priorities for CY 2019;

WHEREAS, these various programs, projects and activities were thoroughly identified, analyzed, and prioritized thru a participative workshop conducted/initiated by the MDC last February 2, 2018 wherein different stakeholders from Social Development Sector, Economic Development Sector and Environment Management Sector participated;

WHEREAS, the Annual Investment Program (AIP) refers to the annual slice of the Local Development Investment Program which constitutes the total resource requirements for all programs, projects and activities like the annual capital expenditures and other operating requirements of the Local Government Unit;

WHEREAS, the 20% Development Fund in the amount of P30,049,140.54 is appropriated as embodied in the 2019 AIP which shall be utilized for programs, projects and activities incidental to the efficient and effective provisions of basic services to the populace;

WHEREAS, P7,817,285.14 is appropriated as Municipal Disaster Risk Reduction and Management Fund (MDRRM Fund) embodied in the MDRRM Plan for the Year 2019 which shall be disbursed and utilized strictly pursuant to the provisions of RA 10121 and its implementing rules and regulations;

WHEREAS, P7,817,285.14 as Gender and Development (GAD) Fund is also appropriated as embodied in the CY 2019 GAD Plan which shall be disbursed and utilized strictly pursuant to the provisions of law and its implementing rules and regulations;

WHEREAS, the herein attached 2019 Annual Investment Program with pertinent attachments reflect the itemized plans, programs and activities, and were indorsed by the local chief executive for appropriate action;
