RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. KARLO ALEXEI B. NOGRALES, DISTRICT REPRESENTATIVE, 1ST DISTRICT OF DAVAO CITY, CHAIRMAN, COMMITTEE ON APPROPRIATIONS, HOUSE OF REPRESENTATIVES, QUEZON CITY, IN THE AMOUNT OF FORTY SEVEN MILLION PESOS (P47,000,000.00) FOR THE CONSTRUCTION OF RIVER WALL PROTECTION WITH STEEL SHEET PILE AND EMBANKMENT PROJECT LOCATED AT BARANGAY 9, POBLACION, TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, in June 2008, the Municipality of Tigbauan was among the municipalities in the Province of Iloilo ravaged by typhoon “FRANK” which caused tremendous damage to the lives and properties of its people;

WHEREAS, public infrastructures and facilities, such as hanging bridges, municipal and barangay roads and bridges, school buildings, river dikes and ripraps, were damaged by typhoon “Frank” but with the help of the national government and its agencies, several damaged infrastructures and facilities have been repaired or rehabilitated;

WHEREAS, one critical problem of the Municipality that remains is the continuous erosion of its intended beach forest project caused by overflowing high tide and strong water current during rainy season;

WHEREAS, every year the municipality conducts mangrove tree planting activity along the riverbank of the coastal areas of the poblacion to mitigate erosion and to protect the entire poblacion and neighboring barangays from the dangers of flood waters, but the same proved futile in the absence of a river wall/bank protection;

WHEREAS, with this predicament and faced with budgetary constraints, the Municipality of Tigbauan is requesting financial assistance from your good office for the construction of a river wall/bank protection along Barangay 9 (Poblacion), this Municipality which per attached Program of Works by the Office of the Municipal Engineer would cost P47,000,000.00;
