RESOLUTION ADOPTING AND APPROVING THE 2018 PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, Section 116 of Republic Act No. 7160, also known as the Local Government Code of 1991, and Executive Order No. 773, S. 2009, mandates for the further reorganization of the Peace and Order Councils in every Province, City and Municipality;

WHEREAS, DILG Memorandum Circular No. 2015-128 dated November 2, 2015 entitled: Guidelines on Formulation of Peace and Order and Public Safety (POPS) Plan likewise mandates every Provincial, City, Municipal Peace and Order Council and Barangay Peace and Order Committee to formulate a three (3) year term based Peace and Order and Public Safety (POPS) Plan which shall be incorporated in the Comprehensive Development Plan (CDP) of the Local Government Unit;

WHEREAS, an urgent letter from the Municipal Mayor dated April 19, 2018 was received by the Office of the Sangguniang Bayan, requesting for the passage of a resolution adopting and approving the 2018 Peace and Order and Public Safety (POPS) Plan of the Municipality of Tigbauan, Province of Iloilo;
