RESOLUTION AUTHORIZING THE BIDS AND AWARDS COMMITTEE (BAC) AND THE HEAD OF THE PROCURING ENTITY (HOPE) TO PROCEED WITH THE PROCUREMENT PROCESS FOR THE IMPLEMENTATION OF THE PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE USE OF SANGGUNIANG BAYAN OFFICE AND THE FURNISHING OF LABOR, MATERIALS AND EQUIPMENT RENTALS FOR THE CORE LOCAL ACCESS ROAD, BARANGAY BUYU-AN AND SUPA, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO AND TO SIGN THE NECESSARY OR INCIDENTAL DOCUMENTS FOR THE PURPOSE

WHEREAS, the Local Chief Executive in a letter dated June 11, 2018 requested this Sangguniang Bayan for the passage of a *“Resolution Authorizing the Bids and Awards Committee and the Head of the Procuring Entity to Proceed with the Procurement Process for the Implementation of the Procurement of One (1) Unit Passenger Van for the Use of Sangguniang Bayan Office and Furnishing of Labor, Materials and Equipment Rentals for the Core Local Access Road, Barangay Buyu-an and Supa, Municipality of Tigbauan, Province of Iloilo”*;

WHEREAS, the LGU-Tigbauan Bids and Awards Committee has already conducted the required bidding last June 5, 2018;

WHEREAS, the winning bidder/supplier for the one (1) unit passenger van (*Nissan Urvan Premium*) was Iloilo Car Corporation in the amount of P1,979,000;

WHEREAS, the winning bidder for the Furnishing of Labor, Materials and Equipment Rentals for the Core Local Access Road, Barangay Buyu-an and Supa, this municipality was MJ Barcelona Construction and Supply in the amount of P16,744,523.00 and the target completion of this project is 220 calendar days;

WHEREAS, to complete the procurement process, there are still documents necessary for the BAC and HOPE to comply in order to implement the projects such as Purchase Request, Notice to Proceed, Contract or Contract & Agreement, Notice of Award and BAC Resolution. It is therefore imperative that the BAC and HOPE be authorized by the Hon. Sangguniang Bayan to proceed in order to comply with the above-mentioned requirements for the implementation thereof;


NOW, THEREFORE, on motion of HON. DENNIS T. VALENCIA, *Chairman, Committee on Appropriation, Budget, Finance, Accounts and Ways and Means* and duly seconded by Hon. John Gershwin C. Tueres, Hon. Ariel I. Bernardo, Hon. Suzette Marie Hilado-Banno, Hon. Neri T. Camiña, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares and Hon. Ronnie T. Paguntalan;

RESOLVED, to authorize the Bids and Awards Committee and the Head of the Procuring Entity to Proceed with the Procurement Process for the Implementation of the Procurement of One (1) Unit Passenger Van for the Use of Sangguniang Bayan Office and the Furnishing of Labor, Materials and Equipment Rentals for the Core Local Access Road, Barangay Buyu-an and Supa, Municipality of Tigbauan, Province of Iloilo and to sign the necessary or incidental documents for the purpose,

RESOLVED FURTHER, to furnish copies of this Resolution to the Office of the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, BAC Office, and all concerned for their information and/or appropriate action.
